Chardonnay Vintage 2005

This Yarra Valley Chardonnay is made from premium Chardonnay grapes and shows a lovely complexity of flavours, including peach and zesty acid, complemented by savoury oak character.

Pinot Noir Vintage 2004

The Wine displays the classic plum and cherry character for a cool climate Pinot Noir with a touch of spice. The velvet texture together with its rich and lingering finish was achieved through maturing and fermenting in French and American oak barriques.



Shiraz Vintage 2004

This soft rich wine is made from Shiraz grapes. It captures distinctive pepper and gentle oak flavours. Sweet berry fruit aromas, and hints of white pepper.

Cabernet Merlot Vintage 2001 Magnum bottle (1.5l)

In this Cabernet Merlot we look to retain all the best characters of each variety. The Cabernet provides structure and body balanced by the soft flavour characteristics of Merlot. This versatile wine exhibits a complex bouquet of rich cherry and plum fruit with a violet floral background.

Cabernet Sauvignon Vintage 2004

This cellar release has a long, silky palate with nice juicy fruit flavours capturing the rich blackberry character of this variety. The wine was matured in new French oak barriques to add a subtle and complex flavour. This is one to keep.
